## Massilly Group Relocates Production to Brantford



The Massilly Group, a leading supplier of metal food packaging products worldwide has announced its subsidiary, Massilly North America Inc., will relocate and expand its North American production operations from Mississauga to a larger facility in Brantford. Ontario.

The company has purchased the 207,317 square foot, former home of Raymond Industrial Equipment at 406 Elgin Street, and brings a \$14 million investment to Brantford. They currently employ 70 highly skilled technical workers and have plans to expand, projecting the creation of 15 new positions in the near future.

Massilly North America Inc. provides Twist Caps, Capping Machinery and Easy Open Ends to the food and beverage industry throughout Canada, the United States, Mexico and South America.

## Wipro Technologies Open Technical Support Centre

## Lanca Continues Downtown Revitalization



Lanca Contracting Limited and Blossom Ave Investments have purchased the former Castelli Bakery property on Dalhousie Street in downtown Brantford. The property will be the site of a six-story student residence with 100 to 160 beds.

"This new project is an exciting addition to the downtown revitalization," said Lanca president Nathan Lancaster. "We're proud to continue to be a leader in reconstructing Brantford's core."

Lanca is a general contractor that has completed numerous projects in Brantford and Brant County, as well as in Haldimand, Norfolk and Oxford counties.

Nathan's father Keith Lancaster started the construction company in 1972 and he is also the owner of Blossom Ave Investments. He remains with Lanca Construction as the company's senior adviser. Blossom Ave Investments has been constructing, managing and improving industrial and commercial space in Brantford for more than 25 years. The company has attracted clients from as far away as British Columbia and Texas.

Blossom Ave Investments recently purchased the property at 180 Dalhousie Street, which had been vacant for a number of years. In addition to that property, they also acquired adjacent properties to build this new residence.

Lanca has been in preliminary meetings with Laurier representatives and has been discussing various designs with them. The project is being timed to coincide with Laurier's increased enrolment

"We're going to be getting rid of a vacant space in the downtown and putting up a very attractive residential building," Lanca said. "The time frame will depend on demand but we're planning for it to be ready by September 2014."

Thomas Bindschedler, CEO of the Massilly Group, said, "Brantford is an ideal location for us because of its close proximity to our core markets in Canada and the United States, its manufacturing-friendly business environment, and our ability to retain and add to our highly skilled workforce. Support from the local government and access to skilled employees from nearby Mohawk College and Wilfrid Laurier University were key to our decision."



Franchising your business can be a great way to grow your business. When you franchise your business, you allow others to use your brand, marketing and processes for a fee. Franchisees pay you for the use of the systems you've developed to duplicate your success.

Franchising a business is not for start-ups or businesses that haven't tested, optimized and proven their systems.
- 4. Do you have more than one location now? Deciding to franchise your business when you have only one location is risky. Until you've "transplanted" your successful business to another location at least once, you won't know how much of your business' success is dependent on local conditions.
